1. Purpose and introduction of the Report

Purpose of the Internal Audit Function and IA Report

- The fundamental role of Internal Audit is to provide non-executive members of BoD, shareholders and senior management with independent assurance on the adequacy, effectiveness and efficiency of the system of internal control and to report major weaknesses together with recommendations for improvement;
- To enable effective outcomes, internal audit provides a combination of assurance and consulting activities. Assurance work involves assessing how well the systems and processes are designed and working, with consulting activities IA supports the improvement of systems and processes where is necessary;
- Internal Audit is obligation which is required with the Law on Trade Companies;
- In accordance with the Law on Trade Companies, the Internal Audit is responsible for preparing annual and semi-annual report on the operation of the internal audit.

2. Summary of the main activities in 2018

Main Internal Audit Activities in 2018

- During the 2018 Internal Audit Function independent assurance on the adequacy, effectiveness and efficiency of the system of internal control was performed through ISO 9001; ISO 14001 and ISO 45001 Internal Audit Process;
- During this process following internal audits were performed:
 - Audit of Production in Quarry; Audit of Production in Factory; Audit of Administration; Audit of Quality Control; Audit of Maintenance; Audit of Management and Integrated Management System;
- Implementation of measures will improve the efficiency and effectiveness of internal controls and audited business processes.


Investments

- The Sivec Quarry Machine Park with 6 new machines has been renovated, which has increased the efficiency of a number of processes within the Quarry;
- The Processing Plant Machine Park with 3 new machines has been renovated, which has increased the efficiency of a number of processes within the Processing Plant;
- A significant amount of money for containers and kiosk cabins has been singled out, and in this way space for wardrobes and mini canteens is provided for all employees in the Quarry;
- Realized 63% of the projected budget for 2018 year.

- One (1) regular inspection by the State Inspectorate for Protection and Rescue in the Sivec Quarry no remarks;
- One (1) regular inspection supervision in Processing Plant no remarks;
- Organized and conducted training of the Emergency Reaction Forces of Mermeren Kombinat AD Prilep, and within, the Teams for: Fire Protection and Explosion; First Medical Assistance; Mining Accidents and Evacuation;
- In 2018 year, there were 21 work-related injuries and were all of an easier character and for which the Safety Index records are kept, which is submitted after each completed month to the Executive Director.

 - ISO 45001:2018 Certification audit


For the period of 2018, the Geological Department of Mermeren Kombinat AD Prilep had realized the following goals:

In 2018 were organized 35 trainings for employees on various topics:


- Increasing the effectiveness and eficiency;


